GUIDELINES

- 1. World Vision and its Area Development Projects booking are not applicable in the sales commission program.
- 2. Partner Agent will receive 5% commission from the total payment of the guest he/she referred to at the end of the month.
- 3. Partner Agent may refer its client to Marketing Department to avail a 5% discount based on the Published Rate. Guest referred must present the Partner Agent's ID in case the agent cannot come during reservation or ocular visit. Daluyan will issue the said Partner Agent ID.
- 4. Generated commission of agents will be paid in check or be deposited to his/her BPI Account.
- 5. The agent should accompany his/her referral to the booking officer for reservation to validate his/her commission. If an agent cannot be able to accompany his/her referral for reservation, his/her client shall be instructed to present the Partner Agent's Identification card to the front desk staff for booking to credit the commission.
